Every member of this caucus was appalled by the nature of this mail piece which was used as an attack on our colleague Assemblyman Kevin O'Toole. It was inappropriate and offensive, and it does not represent the values embraced by our party.



We thank you for your attention to this matter, and we hope that you support our position.






